OFFICE: MAHALAKSHMI MANDIR, NEAR VICTORIA GARDEN (TILAK BAUG) BHADRA, AHMEDABAD.

IN FUTURE ACCORDING TO RULES & REGULATIONS AND DEMAND BY THE MEMBERS OF THE SAMAJ, HEAD OFFICE CAN BE ESTABLISHED ANYWHERE IN AHMEDABAD.

MEMBERSHIP

ELIGIBILITY:

ANY SARYUPAREEN BRAHMAN LIVING IN GUJARAT STATE CAN BECOME A MEMBER OF THIS ORGANIZATION.

MEMBERSHIP FEE (LIFE TIME): Rs. 501.00

NON-ELIGIBILITY (DISSMISSIAL FROM MEMBERSHIP)

IF ANY MEMBER FAILS TO ABIDE BY THE RULES AND REGULATIONS SET BY THE ORGANIZATION OR WORKS AGAINST THE WELFARE OF THE ORGANIZATION, HE/SHE CAN BE DISSMISSED FROM HIS MEMBERSHIP. DIMISSAL WILL BE DONE THROUGH A GENERAL MEETING BY MAJORITY.

THE PATTERN OF FORMATION OF ORGANIZATION

A) GENERAL COUNCIL:

- 1) EVERY MEMBER OF THE ORGANIZATION IS ALSO A MEMBER OF THE GENERAL COUNCIL.
- 2) GENERAL COUNCIL'S MEETING WILL BE HELD ANNUALLY. DATE, TIME AND PLACE OF THE MEETING WILL BE DECIDED BY EXECUTIVE COMMITTEE.
- 3) IN THIS MEETING THE MEMBERS WILL HAVE THE RIGHT TO PRESENT THEIR THOUGHTS REGARDING THE WORKING OF THE ORGANIZATION.
- 4) ANY CHANGE IN THE CONSTITUTION WILL BE DONE ONLY BY THE MAJORITY VOTE OF THE MEMBERS PRESENT IN THE MEETING.
- 5) BUDGET OF PREVIOUS YEARS EXPENSES WILL BE PRESENTED IN THIS MEETING.
- 6) BUDGET OF NEXT YEAR'S EXPENSES WILL ALSO BE PRESENTED IN THIS MEETING.

- 7) ORGANIZATION'S ACCOUNTS WILL BE AUDITED BY AN ACCOUNTANT AND THEN WILL BE PRESENTED TO ITS MEMBERS IN THE GENERAL MEETING.

EXECUTIVE COMMITTEE

NUMBER OF MEMBERS IN THE COMMITTEE WILL BE NOT MORE THAN 31.

- A) **APPOINTMENT:** APPOINTMENT OF THE MEMBERS OF THE EXECUTIVE COMMITTEE WILL BE DONE THROUGH THE VOTING IN GENERAL MEETING. MEMBERS OF THE EXECUTIVE COMMITTEE WILL SELECT OFFICE HOLDERS AMONG THEM. THE MEMBER SELECTED FOR THE POST OF PRESIDENT SHOULD BE MORE THAN 35 YEARS OLD.
- B) **TENURE:** TENURE OF THE EXECUTIVE COMMITTEE WILL BE OF TWO YEARS. IF NEED ARISES ITS TENURE CAN BE EXTENDED FOR ONE YEAR MORE.
- C) MEETING OF THE EXECUTIVE COMMITTEE WILL BE HELD BY EVERY TWO MONTH.
- D) REGIONAL MEETING CAN BE HELD AT ANY TIME & AREA OF GUJARAT.
- E) **RIGHTS AND DUTIES:**
- 1) TO LOOK OVER ORGANIZATION'S MOVABLE AND UNMOVABLE PROPERTIES.
 - 2) TO PLAN AND CARRY OUT THE ORGANIZATIONS WORKS.
 - 3) TO PRESENT THE EXPENSES OF PREVIOUS YEAR AND THE BUDGET OF NEXT YEAR IN THE GENERAL MEETING.

- 4) EXECUTIVE COMMITTEE WILL BE RESPONSIBLE FOR PLANNING AND FUNCTIONING OF THE ORGANIZATION.

RIGHTS AND DUTIES OF THE OFFICE BEARERS

PRESIDENT:

- 1) WILL BE THE LEADER OF THE ORGANIZATION AND WILL BE THE HEAD OF EVERY MEETING.
- 2) WILL BE RESPONSIBLE FOR EVERY WORK OF THE ORGANIZATION.HIS PERMISSION WILL BE REQUIRED IN ANY IMPORTANT DECISION.
- 3) OTHER POWERS AND DUTIES WILL BE DECIDED BY THE EXECUTIVE COMMITTEE.

VICE-PRESIDENT:

IN THE ABSENCE OF THE PRESIDENT, Sr.VICE PRESIDENT WILL HAVE EVERY RIGHT OF THE PRESIDENT.

GENERAL SECRETARIES:

- 1) WILL BE THE HEAD OF THE OFFICE.
- 2) WILL BE RESPONSIBLE FOR EVERY PAPER WORK OF THE ORGANIZATION.
- 3) ORGANIZATION'S ADMINISTRATIVE SYSTEM WILL BE LIABLE ON GENERAL SECRETARIES.

- 4) IMPLEMENTATION OF THE PLANS AND PURPOSE OF THE ORGANIZATION 'S LIABILITY WILL BE ON THE GEN. SECRETARIES.

TREASURER:

- 1) THE FUNDS OF THE ORGANIZATION WILL BE MANAGE BY THE TREASURER IN ANY BANK (SELECTED BY EXECUTIVE COMMITTEE).THE BANK OPERATION WILL BE DONE JOINTLY ANY TWO OUT OF PRESIDENT, ONE GENERAL SECRETARY AND A TREASURER.

GENERAL RULES:

- 1) THE FUNCTIONAL YEAR OF THE ORGANIZATION WILL BE FROM APRIL TO MARCH.
- 2) FUNDS OF THE ORGANIZATION WILL BE RAISED THROUGH MEMBERSHIP FEES, DONATIONS AND DIFFERENT FUND RAISING PROGRAMMES.
- 3) IF ANY MEMBER OF THE EXECUTIVE COMMITTEE REMAINS ABSENT WITHOUT NOTICE IN THREE CONSICUTIVE MEETINGS HE WILL BE DISSMISSED FROM HIS POST.
- 4) IN THE CASE OF DEFORMATION OF THE ORGANIZATION, THE FUNDS WILL BE PASSED ON TO A DIFFERENT ORGANIZATION DOING SAME WORK.
